



## IMPORTANT INFORMATION FOR PARENTS

### Financial Information:

Upon enrollment, a deposit of \$500 per child, per session will be paid to Circle F Dude Ranch Camp. All fees are due and payable in full by May 1st, unless other arrangements have been made. Registrations after May 1st should include payment of tuition in full. Payment by check is preferred. However, payment can be made by Visa, MasterCard or Discover. For international campers, payment can also be made by bank transfers. Please call or fax our office for details.

Tuition covers room & board, supervision, basic programs (including horseback riding), program supplies, laundry bag, yearbook and one camp t-shirt.

### Cancellation & Refunds:

In case of cancellation before April 1st, a refund of \$300 will be given, plus any fees paid to the camp. After April 1st, the full deposit is forfeited. There will be no reduction or refund of fees for campers sent home for behavioral problems, homesickness or non-adjustment to the camping experience or for late arrivals/early departures. No refund is available for discontinuation of the camp season due to acts of God, natural disasters, acts of war or epidemics.

### Additional Expenses:

**Camp Store Account:** We suggest \$25 per week per camper for a camp store account. This covers personal spending money for items purchased at the camp store such as film, postage, stationery supplies, toiletry items, sweatshirts and limited drinks & food items. Due to administrative costs, remaining balances less than \$10.00 will not be refunded. Bills will be sent if amount owed exceeds \$10.00. Campers may not store personal cash in their cabins.

**Laundry:** Campers are provided a wash, dry, and fold service. Campers' clothes are laundered at least once per week. Clothing must be WELL MARKED to prevent possible mix-up or loss.

Campers are also provided a take-home laundry bag. Additional cost for laundry is \$15 per week.

**Paintball:** An extra charge of \$65 per week will be charged for campers who wish to participate in this activity, which is held three times per week (4th Session, which consists of 10 days, will be considered one week).

**Excursion:** For each session we will have an offsite excursion, for which there is an additional charge of \$130. We will be

visiting different entertainment parks for each session. Additional information will be available as to which parks we will be visiting closer to opening day – check our website for updated information.

**Travel to/from Airport:** If you require transportation for your camper to and/or from the camp, we charge \$95 each way.

### Other Useful Information

**Tutoring:** Tutoring can be provided on limited basis. Please call for more information.

**Visitation:** If you feel it is necessary to visit your camper, please call the director to make arrangements. Through years of experience we have found that visitation can be disruptive to a camper's experience; therefore we do not provide a specific time for visitation during any of the sessions.

**Phone Calls:** We do not encourage phone calls as we feel that they create the possibility of jeopardizing the success of your camper's experience. We do allow short incoming phone calls during meals. The number for this phone will be sent to each family prior to arrival at camp. The Director will NOT give permission for campers to use the telephone to call out of camp unless it is absolutely necessary. We do not allow cell phones. We have found that this particular policy increases the odds of your camper reaping the maximum benefit from the camp experience.

**Acknowledgement/Camp Forms:** Upon enrollment, you will be sent an acknowledgement. Approximately one month prior to the start of camp you will be sent a package of forms including an activity selector, a suggested list of items (clothing, etc) to bring to the camp, a medical form (examination required prior to arrival at camp), and other pertinent information.

**Accidents/Illnesses:** Circle F is proud of our excellent health record over the last 58 years. We practice SAFETY FIRST, always and everywhere. We have a full-time nurse on duty at the camp for all minor accidents/illnesses.

We ask that all campers come to camp with medical insurance information in the unlikely event that they will require it. All medical expenses are for the account of the camper/parent. Our nurse will collect medication and instructions from the camper's physician and dispense medication per instructions. Upon check-in you will have the opportunity to meet and speak personally with our nurse.



**Letter Writing:** We leave this up to each individual camper/family. If you wish your child to write home, please provide them with the materials.

**Climate:** Our climate is rather ideal for camping. Regular Florida summer clothing is adequate. Our days are warm but pleasant and the nights are cool.

**Special Conditions:** If your child has special needs, please call us prior to enrolling. Children who are habitual bed-wetters cannot be accepted as campers. It is not fair to the child, to the other campers, or the counselors. We also do not accept children with severe learning disabilities or children in therapy for emotional problems.

**Smoking/Drugs/Alcohol:** Campers who smoke, or use drugs or alcohol will not be acceptable in camp. If campers are found with such items in their possession, they will immediately be dismissed. All Circle F Staff is subject to the same rules and these are enforced vigorously.

**Food Packages:** Campers are supplied with plenty of appetizing and nutritious food. They are NOT allowed to have food packages sent in or brought to them. Any food packages arriving in camp WILL NOT BE DELIVERED. Birthday cakes are provided by the camp free of charge.

**Loss of Equipment, Personal Articles & Clothing:** The camp is not responsible for loss of personal articles or clothing by theft, carelessness of camper, or other causes.

**Tax Deductible:** In some cases summer camp may be tax deductible as child care. Please consult your tax professional.

**Photos:** Photos may be taken of your camper for promotional or other use. By signing the application, you are giving Circle F permission for the commercial use of all photos taken of your child(ren).

**Directions From:**

**South Florida**

*(Boca Raton, Ft. Lauderdale, Miami, etc)*

Go North on the Florida Turnpike to Yeehaw Junction Exit (exit #193). Go West on highway 60 exactly 40 miles to entrance signs (directional sign on the left side of the road). Follow signs into camp. Approximate driving time from Miami area is 3 hours.

**Orlando Area**

Go West on Interstate 4 to exit #55, which is Highway 27. Go south approximately 22 miles to Lake Wales. Go East on Highway 60 exactly 6 miles to entrance signs (billboard on right, directional sign on the right side of road). Follow signs into camp. Approximate driving time from downtown Orlando is 1 hour 15 minutes.



**Tampa Bay Area**

Go East on Highway 60, through Bartow. Stay on Highway 60. When you pass over Highway 27 at Lake Wales, continue East on Highway 60 exactly 6 miles to entrance signs (billboard on right, directional sign on the right side of the road). Follow signs into camp. Approximate driving time from Tampa is 1 hour 15 minutes.

**Southwest Florida (Naples, Ft. Myers, etc.)**

Go North on Interstate 75 to Highway 60 exit at Tampa/ Brandon. Go East on Highway 60 through Bartow. Stay on Highway 60. When you pass over Highway 27 at Lake Wales, continue East on Highway 60 exactly 6 miles to entrance signs (billboard on right, directional sign on the right side of the road). Follow signs into camp. Approximate driving time from Naples is 3 hours.

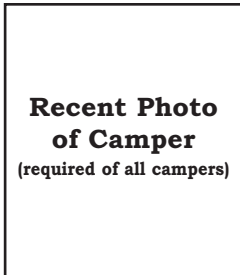
**Discounts:**
